The release of **Executive Orders VR-203 and VR-204 – Revision N** offers:



- **Executive Order VR-204**: The VST ZERO option with INCON ISD. California GDFs can now convert their costly vac assist systems to balance EVR with VST EVR hanging hardware and improve the station's Return On Investment (ROI). This low-cost solution allows for the Franklin Fueling Systems INCON ISD, Flow Meters, and CAS to remain in place. Simply remove the dispenser vapor pumps, install appropriate dispenser vapor piping, upgrade the INCON ISD software, and install VST EVR balance hanging hardware.
- **Executive Orders VR-203 and VR-204**: The introduction of the VST GREEN MACHINE™ to the California EVR market. This next generation EVR processor operates as an active tank pressure management device that captures and controls fugitive emissions to improve your air and water quality. It is designed for single vent applications while offering a small footprint, simple installation, and flexible mounting options. The VST EVR GREEN MACHINE™ is approved for balance systems with Veeder-Root In-Station Diagnostics (ISD) and carries CARB and TÜV Certifications, as well as an ETL Listing.
